- Installation of gate, security and guardian program caused some changes on the budget

## 2018-2019 Budget Review Safety Line Item - Mulling

- \$2.5K stipend for clothing not the firearm up front
- Also \$5K to pay per semester paid at the end of each semester prorate it if they leave early
- \$2.5K \$100 per day for 10 days if we need a substitute
- Tested 2x a year rigorous testing
- Currently we have one guardian
- The guardian does not own the gun the Sheriff department issues the gun
- If our guardian does not pass the test we need a plan B
- Plan B
- o Possibly use the second guardian from Berkley Elementary's second guardian
- o OR Signal 15 pay a ? hundred for a county officer to come from the police department
- OR Have a second guardian to BAMS
  - Have to wait for the test to come up again
  - It takes the person out from the school for three weeks to take the training
- Our insurance school package has a shooting coverage
  - o Covers the guardian as they are acting on behalf of the school active shooter liability
- Sheriff maintains the guardian training and arms
- BAMS guardian is undercover
- School board guardians wear a uniform on the campus
- MOTION
  - Add \$5K per semester compensation \$10K

- o Add \$2.5K stipend
- o Approve \$2.5K for fill in guardian
- For this year
- o MOTION to update the budget
