<u>Update on Motion for Legal Opinion from June 22, 2021 meeting</u> • Discussion

Chair Mulling informed the Board of the progress of receiving a legal opinion based on action taken at the June 22, 2021 meeting. Tim Campbell with Clark, Campbell, Lancaster & Munson, P.A. (Lakeland, Florida) was contacted to review requisite documents and provide a legal opinion on courses of action available to the BAMS Board of Directors based on recent developments with Polk Pre-Collegiate Academy (PPCA).

Based on the Chair's discussion with Mr. Campbell's on his legal review:

- BAMS Board of Directors have the right to terminate the operating agreement with PPCA.
- Both parties would be better served by making a new agreement to better define the terms and responsibilities.
- If both parties can develop and agree to a new agreement, then the termination could be rescinded.

Board members were concerned for teachers hired by BAMS, whose employment contract is with BAMS, and provided to PPCA. As part of the legal opinion, the Board was advised that the PPCA principal would have no authority to evaluate, discipline, terminate or place any related documents in a teacher's personnel file. The Board did reach a consensus that the principal should have access to the campus, access to staff (teachers) employed by BAMS, work in good faith for students at PPCA once an employment agreement has been fully executed by the principal, PPCA and the Polk County School Board.

Chair Mulling expects to have the letter from Tim Campbell by July 5, 2021. The Chair will sign the letter on behalf of the Board and deliver the letter to the PPCA Board Chair Henry Manson.

The BAMS Board also extended an invitation to the PPCA Board to present their future plans at the next BAMS Board meeting on August 17, 2021. Based on the PPCA presentation of their plans, BAMS will be better suited to determine its future needs.
